

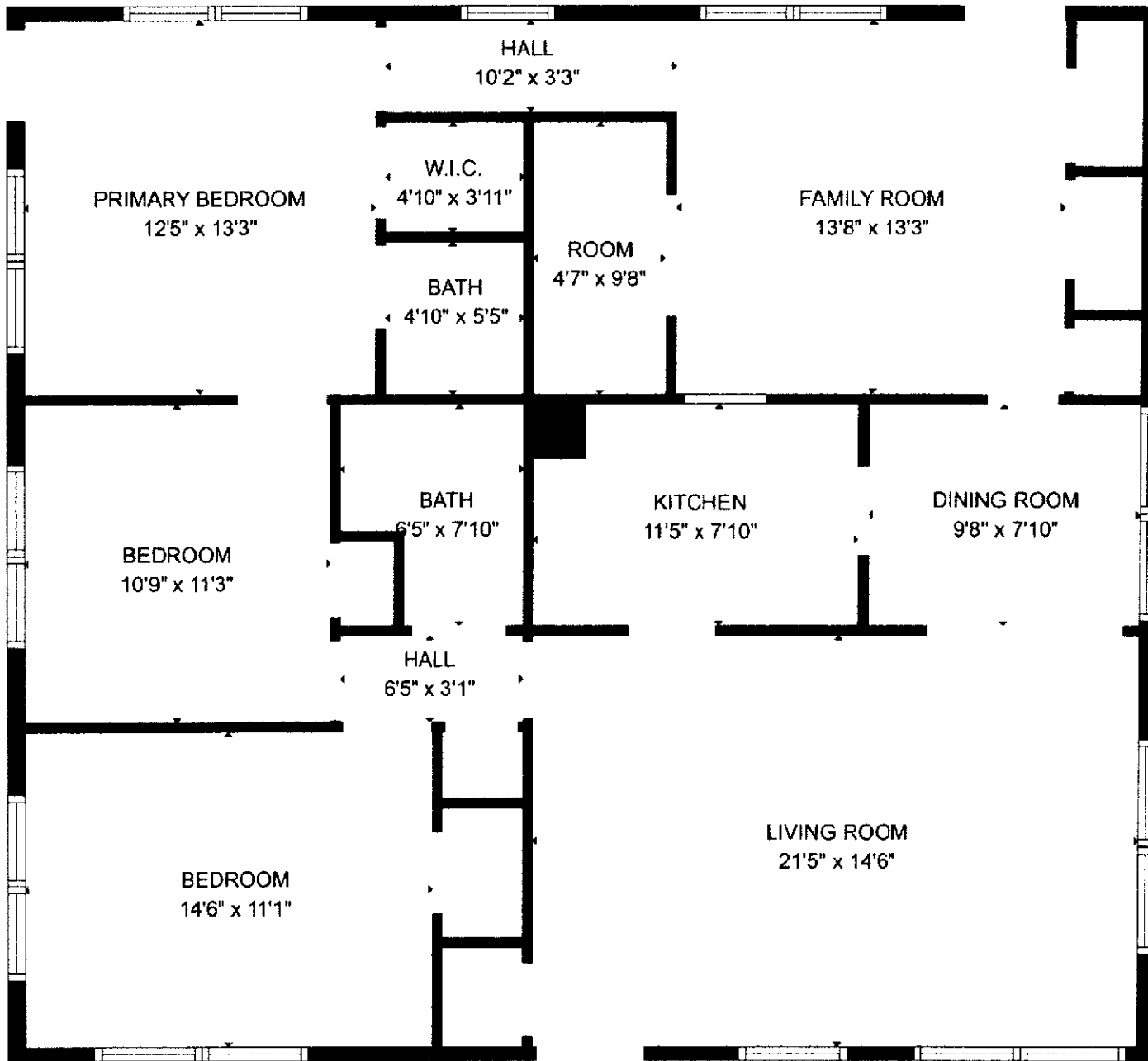

Information About Brokerage Services
